(II) your consent to do so for a specific purpose; or (III) process your data to comply with a legal obligation.

3. Retention of your personal information.

COREBI will retain your personal information for as long as necessary to fulfill the purposes for which

it was collected or as necessary to comply with our legal obligations, resolve disputes, and maintain

appropriate business records. Once the purpose has been fulfilled, your personal information will

remain blocked due to the possibility of legal and governmental requirements and until its limitation

period has expired.



4. Disclosure of personal information.

COREBI may share your personal information with an affiliate.

In addition, COREBI reserves the right to provide information when required by law or to comply

with valid legal process (such as a search warrant, subpoena or court order), as well as to protect the

rights or property of COREBI, including, among others, in the event of a transfer of control of COREBI

or most of all its assets, or during emergencies when security is at risk.

5. Where your personal information is stored and what your access rights are. Information storage
